## Personal Information We Collect

Unity2u.community will process your personal data as listed below which have/has been provided by you to Unity2u.community such as:

- Name, identity card number/passport number, and date of birth;
- Contact details including address, phone number(s), and email address;
- Occupation, income and source of wealth; and d. Any other personal data required for the purpose as set out below.

Unity2u.community may obtain your personal data from a variety of sources, including but not limited to:

- When you sign up to purchase our products and services from us or our business partners;
- When you register your interest with us or our business partners to purchase the products and services;
- From third parties connected with you, such as employers, joint account holders, security providers or guarantors, representatives, other partners in your partnership, or through our corporate customers or corporate security providers where you are a director, shareholder, officer, or authorized signatory;
- When you visit our websites or social networking sites;
- Pursuant to any transaction or inquiry or communication made with or to us or our business partners; and/or

- for audit and risk management;

- third party cryptocurrency (or virtual or digital asset) service providers/ associate/partners to use this information to screen and process a relevant transaction;
- any subcontractors which any of our service providers, agents, suppliers, delegates or contractors may appoint from time to time to provide them with services in connection with the Platform or the Services that we offer to you, and their directors, officers, employees, representatives, agents or delegates
- to respond to your enquiries and complaints;
- to produce data, reports, and statistics which have been anonymized or aggregated in a manner that does not identify you as an individual;

- for crime detection, prevention and prosecution;
- for any other purpose that is required or permitted by any law, regulations, standards, guidelines, and/or by relevant regulatory authorities;
- for such other purposes that are incidental or ancillary or in furtherance to the above purposes.

We will ask for your consent before using your personal information for a purpose other than those that are set out in this Privacy Notice and the privacy terms of any of your agreement(s) with Unity2u.community.

## Disclosure of Your Personal Information

During the provision of our products and services to you and the management and/or operation of the same, we may disclose your personal information (to the extent necessary) to the following third parties:

- Unity2u.community including the directors, officers and dealer's representatives;
- companies and/or organizations that act as our agents and/or professional advisers;
- companies and/or organizations that assist us in processing and/or otherwise fulfilling transactions that you have requested;
- companies and/or organizations that assist us in providing value added services that you have requested;
- Unity2u.community's advisers (including but not limited to accountants, auditors, lawyers, financial advisers, consultants or other professional advisers);
- Unity2u.community's merchants and strategic partners;
- any person notified by you as authorized to give instructions or to use the account(s)/facility(ies) or products or services on your behalf;
- any person intending to settle any moneys outstanding under the facility(ies) granted by us to you subject to your prior authorization; i. any rating agency or credit reporting agency;
- any person connected to the enforcement or preservation of any of our rights under your agreement(s) with us;
